Votes by your state legislators on key small business issues are listed here. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislator's attitudes toward small business. Please thank those legislators who supported small business.

BOTH CHAMBERS

1. Price Controls (2025 - AB44): Creates redundant new regulations that restrict retailers' ability to set market rate prices for many common consumer products without requiring a state of emergency declaration and imposes harsh penalties and fines on business owners. **A "NO" vote supports the NFIB position.** Passed the Senate 14-7. Passed the Assembly 24-18. Vetoed by the governor.

2. Restaurant Alcohol Sales (2025 - AB375): Allows restaurants to offer to-go and delivery options for mixed drinks and cocktails, granting independent restaurants parity with large beverage retailers. **A "YES" vote supports the NFIB position.** Passed the Senate 20-1. Passed the Assembly 41-1. Signed by the governor.

3. Employer Free Speech (2025 - AB434): Imposes confusing, conflicting, and restrictive "captive audience" limitations on employer speech in the workplace and exposes business owners to potential fines and litigation. **A "NO" vote supports the NFIB position.** Passed the Senate 13-8. Passed the Assembly 27-15. Vetoed by the governor.

4. Right to Repair (2025 - AB407): Permits independent repair shops to service and repair certain personal mobility and home health service products. **A "YES" vote supports the NFIB position.** Passed the Senate 21-0. Passed the Assembly 42-0. Signed by the governor.

5. Employer-Paid Family Leave (2025 - AB388): Expands Nevada's existing public sector paid family leave program to private sector employers, extends the benefit from 8 to 12 weeks, and requires employers to pay the cost of wage replacement. Penalties for compliance errors include significant fines and civil litigation. **A "NO" vote supports the NFIB position.** Passed the Senate 11-9. Passed the Assembly 26-16. Vetoed by the governor.

6. Forms of Accepted Payment (2025 - SB358): Stipulates that state and local government entities accept payment by debit card, credit card, check, or electronic money transfer for any fee, fine, or tax. **A "YES" vote**

supports the NFIB position. Passed the Senate 21-0. Passed the Assembly 42-0. Signed by the governor.

7. Business Courts (2025 - AJR8): Amends the state constitution to create a business court in Nevada to ensure specific business matters and disputes have dedicated jurists with subject matter expertise. **A "YES" vote supports the NFIB position.** Passed the Senate 17-4. Passed the Assembly 40-2. Required to pass the legislature a second time in 2027 before being placed on the 2028 general election ballot for voter approval.

8. Business Licensing (2025 - SB373): Creates a single, unified multi-jurisdictional business licensing process for operators in Clark County. **A "YES" vote supports the NFIB position.** Passed the Senate 21-0. Passed the Assembly 42-0. Signed by the governor.

9. Wage and Hour Conformity (2025 - SB8): Aligns Nevada labor law with federal standards and recent Nevada Supreme Court decisions by incorporating provisions of the federal Portal-to-Portal Act and Fair Labor Standards Act regulations into Nevada law. **A "YES" vote supports the NFIB position.** Passed the Senate 19-2. Passed the Assembly 33-4. Signed by the governor.

SENATE ONLY

10. Business Licensing Fees (2025 - SB240): Reduces state business license fee to \$100 for small businesses with 50 or fewer employees. **A "YES" vote supports the NFIB position.** Passed the Senate 21-0. Died in the Assembly.

11. Farm Labor Mandates (2025 - SB 172): Permits Nevada farmworkers to collectively bargain and unionize, creates a new dedicated regulatory structure to dictate and modify wages and benefits specific to the agriculture industry and workplace, and exposes farmers to increased litigation, liability and associated costs. **A "NO" vote supports the NFIB position.** Passed the Senate 13-7. Died in the Assembly.
