Votes by your state legislators on key small business issues are listed here. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislator's attitudes toward small business. Please thank those legislators who supported small business.

## BOTH CHAMBERS

- 1. Income Tax (2025 - HB1001):** Lowers the income tax rates from 3.9% to 3.7% and the corporate rate to 4.3%. **A "YES" vote supports the NFIB position.** Passed the Senate 27-6. Passed the House 79-17. Signed by the governor.
- 2. Phantom Damages (2025 - HB1204):** Prohibits phantom damages on medical charges. **A "YES" vote supports the NFIB position.** Passed the Senate 18-17. Passed the House 71-18. Signed by the governor.
- 3. Organized Retail Theft (2025 - SB300):** Amends current law to create the criminal offense of "organized retail theft," providing business owners with an avenue to press charges and provide a more descript legal path for prosecution. **A "YES" vote supports the NFIB position.** Passed the Senate 34-0. Passed the House 98-0. Signed by the governor.
- 4. Homestead Property Taxes (2025 - HB 1103):** Increases the homestead property tax credit to \$675. **A "YES" vote supports the NFIB position.** Passed the Senate 34-0. Passed the House 94-0. Signed by the governor.
- 5. Income Tax (2026 - HB1001):** Lowers the income tax rate from 3.7% to 3.5% and the corporate tax rate from 4.3% to 4.1%. **A "YES" vote supports the NFIB position.** Passed the Senate 28-4. Passed the House 88-9. Signed by the governor.
